POLICY ADVOCACY FOR INCLUSIVE EDUCATION IN UGANDA

During the quarter, CIDD-UG successfully conducted **one** education improvement policy advocacy engagement meeting, The meeting, whose objective was to ignite and influence the leaders' attitudes towards prioritizing inclusive education in Pallisa and Budaka, was attended by a cross section of **35 female** and 37 male technical, political and other key education stakeholders in the respective Districts. Altogether 72 leaders benefited from this engagement in the two districts. Education and Sports Sector has the country's mandate to offer education as a basic human right. The core objective is to equip learners/ students/trainees with relevant knowledge and skills necessary for socio-economic transformation and development. This is in line with the fourth Sustainable Development Goal (SDG) which emphasizes inclusive and quality education for all as well as the promotion of lifelong learning. The sector embraced inclusive education and evidently committed itself to bringing about inclusion of learners at every level of education regardless of Mrs Kaidu Ketty Gender officer Kibuku DLG



their strengths or weaknesses. Despite achievements registered, a number of challenges not limited to Financing and data on learners with disability for appropriate planning; the data mostly captured for learners with disabilities refers to children with visual or hearing impairments. Data on learners with intellectual disabilities, multiple disabilities or psychosocial disabilities among others is not often captured and this affects planning for their needs.

It was against such background that CIDD-UG during the period under review, through her strategic policy influencing project, planned and conducted policy advocacy for inclusive education in the eastern region. The immediate outcome of these meetings were action plans drawn on how and when to generate data for learners In the District to inform planning apart from conducting joint CSO and Government service inspection to enhance education service delivery in the two Districts including those with special needs.

"I want to thank CIDD-UG for the wise idea of embanking on challenging government to enhance inclusive education. For it's a fact that Local Governments have not invested in ensuring that there is available data on the learners with Disability. We have continued to plan for disability but without accurate data. This in itself is misleading because it is not possible to plan where there is no data. I request CIDD-UG to continue to help me push for this, only then shall we be able to adequately respond to the unique needs of these learners". Said Kaidu Ketty, Gender officer Kibuku District

BUILDING PARTNERSHIPS BETWEEN CSOS AND LOCAL GOVERNMENTS

During the reporting period, CIDD-UG was able to build new partnership with Action aid and Namutumba District Local Government. The organization has continued being deliberate on creating and nurturing partnership with Government for strategic purposes of enabling civil society participation and addressing shrinking operating space. As development is essentially a locally driven political process, Governments have the unique responsibility to lead sustainable development and to uphold human rights. But their efforts cannot be successful without the inclusive and equitable participation of all actors. Like civil society organizations, the private sector, it was for such reasons that CIDD-UG during the period under review deliberately continued to strengthen civil society partnerships for enabling CSO participation in development processes, beginning with planning and continuing through implementing and monitoring national and local development strategies.

the period under review conducted leaderscitizen Governance improvement debates in Bukedi sub region. One such engagement hosted a cross of **60** section leaders in Bukedi sub region in the category

heads, Chief Administrative officers, District and sub county planners, District speakers, District internal security officers, District police commanders, Resident District commissioners, opinion, cultural and religious leaders, CSO representatives among others. It was purposed to influence leader's attitude and practices towards embracing citizen participation in development planning for their views to be integrated into development plans to ensure that unique needs of the vulnerable groups are catered for. The activity that benefited 25 females and 35 males, was premised on the fact that without active citizen participation or involvement in public affairs, democracy only becomes empty faced. As a result of this engagement leaders were able to appreciate the need for citizen participation but also committed to prevail over public officers to ensure that their development plans reflect citizen's voices and their unique needs.

If Local Governments are to improve on the services to the local population, there is an urgent need for proper revenue mobilization, management and appropriation. Since our region is endowed with valuable natural resources, I push that a percentage of revenue generated from endowments be retained to help in timely response to the unique demands from the local people". COLLABORATED TO ORGANIZE REGIONAL CITIZEN ENGAGEMENT ON POLITICAL AND ELECTORAL REFORMS.

During the period under review, CIDD-UG in collaboration with FOWODE, planned and conducted

citizen engagements to enhance and popularize Citizen demand for political and electoral reforms in Uganda. The objective of these engagements was to push for needed political and electoral reforms ahead 2026 General elections to improve on the level of acceptance of electoral outcome and as well work towards improving the credibility of elections in Uganda. Free and Fair elections are the hallmark of a well-functioning democracy and the foundation of a legitimate and stable government. The general election system consciousness, and the way candidates raise and spend funds during campaigns all have a significant bearing on the kind of elections a society is bound to have and broadly affect the democratic operating environment. The regional meeting that engaged over 100 key election commercialization of politics as being one of the issues that have inhibited active and meaningful participation of citizens in democratic process, especially women, young people and persons with disability because majority of them are vulnerable

and cannot afford to pay for votes though they can make good leaders. The regional debates inspired the citizens to demand that government strengthens and vigilantly enforces laws against voter bribery and commercialization of politics, demilitarizing electoral processes and allowing free political party involvement to ease meaningful participation of all categories of people in the process.

As an outcome of this engagement, a cross section of participants in Bukedi expressed the need for adoption of constitutional and electoral reforms that will improve both allocation of resources for service delivery and promotion of good governance as well as reduction of societal inequalities from the national perspective. One of them for example stressed that:

"We urge the Ugandan government to prioritize the process of constitutional reforms, ensuring that all stakeholders are consulted represented. We call upon civil society organizations, members of parliament, political leaders, and citizens at large to actively engage in the process and advocate for a constitution that upholds the rule of law, protects human rights, and reflects the aspirations of all Ugandans. It is time for meaningful reform that strengthens democracy, ensures a sustainable future, and fosters prosperity for all." Adome Anthony, opinion leader from Kaukura sub county Pallisa District.
